

Rules & Regulations

1. Eligibility

- a. All bowlers must be members of USBC (Team Captains are responsible for ensuring all team members meet eligibility requirements).
- b. All teams must be composed of one member of the opposite sex, (for example: three men and one woman or one man and three women).
- c. The tournament committee reserves the right to reject any entry that it deems ineligible.
- d. Not more than 3 bowlers on a team can place more than 1 time in the prize list for position standings

2. Payoff

- a. Payoff is one prize for every 4 entries
- b. Tournament will be paid out within 30 days after the end of the last day of the play.
- c. At least one bowler's monies must accompany entry form. If mailed, envelope must be post marked before November 5, 2018. Make Checks payable to Pacific Avenue Bowl.

3. Format

- a. 3 games will be bowled per squad. Bowlers will not move lanes between games.
- b. Lanes will be oiled between each squad.

4. Entry Close

a. Team entries close November 7, 2018. All squad times are subject to availability. Team Entries will not be accepted the day of the tournament

5. Averages

- a. 2017-2018 highest PAB winter book average; if none
- b. 2017-2018 highest winter book average; if none
- c. 2018 highest summer book average; if none
- d. Current league average of 21 games or more; if none
- e. Bowlers without an average shall use 230 for a man and 230 for a woman.
 - USBC rules 319a-1 thru 4 and 319c will apply.
 - 319a-2 When the previous season's average is used, and at the time of bowling an entrant has a current average for 21 or more games that is 10 pins or more higher than the prior season's average, the current average must be used.
 - USBC rules 319d and 319e will not apply.

6. Handicap

- a. Mixed team events handicap is 90% of 920.
- b. Maximum Mixed Team Average Allowing is 920

7. Tie Scores

- a. In the event of a tie for any paid position, the prize for the position tied and the next position will be combined and equally divided amongst the tied teams and/or doubles.
- 8. Bowler Replacement
 - a. Substitutions must be cleared by tournament committee and will comply with ELIGIBILITY REQUIREMENTS.

9. Bowler's Responsibility

a. It is the bowler's responsibility to notify the tournament committee prior to participation, in writing, if they have ever been rerated in any tournament or by their local bowling association. Failure to do so will result in disqualification.

10. Decisions

a. All Decisions made by tournament committee will be final unless appeal is made in accordance with USBC Rule 329.

11. Violations

a. Teams and/or doubles violating any of the above mentioned rules will be immediately disqualified and will forfeit all fees and prizes.
